Thank you very much. In the meantime, I wanted to pass along the attached final rule, which was just published on Thursday, August 29. The final rule revises the California SIP to remove a general nuisance provision very similar to Ohio's because the inclusion of the nuisance provision is inconsistent with the Clean Air Act.

We look forward to scheduling a meeting to discuss the importance of EPA correcting the Ohio SIP on the same basis.
