**Re: Approval to Cooldown LNG Tank S-101**

Dear Mr. Nielson:

I grant your request for Sabine Pass Liquefaction, LLC and Sabine Pass LNG, L.P. (collectively referred to as Sabine Pass) to commence cooldown of LNG Tank S-101. This approval is based on FERC and PHMSA's review of responses filed on March 31, April 1, 8, 14, 15, 19, and 29 and May 2, 5, 11, 17, 19, 20 and 27, June 2, and June 6, 2022 to the conditional requirements of the March 9, 2022 FERC and PHMSA joint letter *Conditional Approval to Recommission, Cooldown, and In-service of LNG Tank S-101*. This approval is also based on Sabine Pass following all applicable plans and procedures related to tank recommissioning and cooldown and any modification to these procedures would require additional approval.

I remind you that this approval does not alleviate Sabine Pass from satisfying other requirements specified in the July 9, 2019 and March 9, 2022 joint letters from FERC and PHMSA. Sabine Pass must comply with all applicable remaining terms and conditions of the above referenced letters, as well as procedures stipulated in your previous filings. We also note that Sabine Pass must also comply with any applicable Department of Transportation, Pipeline and Hazardous Materials Safety Administration requirements under 49 CFR Part 193. Additional authorizations will be released once Sabine Pass has demonstrated full compliance with the requirements of the joint letters.
