METROPOLITAN POLICE DEPARTMENT REQUEST

1. MPD is respectfully requested to provide forty (40) officers on the north side of Constitution Avenue, NW, between 23rd and 20th Streets, NW to assist with any traffic control, pedestrians, and possible protests along the northern perimeter of the site from 05/03/2020 at 1200 hours until 05/03/2020 at 2200 hours.
2. MPD Harbor and USCG are respectfully requested to have units patrolling the Potomac River alongside the Lincoln Memorial from the Roosevelt Bridge to Haines Point to ensure no individuals or watercraft attempt to access the site from the Potomac River from 05/03/2020 at 1200 hours until 05/03/2020 at 2200 hours.
3. MPD is respectfully requested to have a tow truck available for the duration of the visit to remove any unauthorized vehicles parked in the restricted areas.

U.S. PARK POLICE REQUEST

1. U.S. Park Police is respectfully requested to post “No Parking” signs on the north and south sides of Constitution Ave. St, NW from the west corner of 17th Street, NW going west bound to 23rd Street NW. The restriction should be in effect from 05/03/2020 at 1200 hours until 05/03/2020 at 2200 hours. This is for line of sight concerns, stand-off distance from the site.
2. U.S. Park Police is respectfully requested to **SHUT DOWN ALL VEHICULAR AND PEDESTRIAN TRAFFIC** on Lincoln Memorial Circle, NW. The restriction should be in effect from 05/03/2020 at 1200 hours until 05/03/2020 at 2200 hours. This is for line of sight concerns, stand-off distance from the site.
3. U.S. Park Police is respectfully requested to **SHUT DOWN ALL VEHICULAR AND PEDESTRIAN TRAFFIC** on the northbound lanes of 23th Street from Independence Avenue, SW to Lincoln Memorial Circle, from 05/03/2020 at 0600 hours until 05/03/2020 at 2200 hours.

4. U.S. Park Police is respectfully requested to **SHUT DOWN ALL VEHICULAR AND PEDESTRIAN TRAFFIC** on the north and southbound lanes of 23th Street from Constitution Avenue, NW, to Lincoln Memorial Circle and from Lincoln Memorial Circle to Independence Avenue, SW, from 05/03/2020 at 1200 hours until 05/03/2020 at 2200 hours.
5. U.S. Park Police is respectfully requested to post “No Parking” signs on the east and west sides of Henry Bacon Drive, SW, from Constitution Avenue, NW, to Lincoln Circle, NW. The restriction should be in effect from 05/03/2020 at 0600 hours until 05/03/2020 at 2200 hours. This is for line of sight concerns, stand-off distance from the site.
6. U.S. Park Police is respectfully requested to **SHUT DOWN ALL VEHICULAR AND PEDESTRIAN TRAFFIC** on Henry Bacon Dr, NW, from Constitution Avenue, NW, through Lincoln Memorial Circle NW. The restriction should be in effect from 05/03/2020 at 0600 hours until 05/03/2020 at 2200 hours. This is for line of sight concerns, stand-off distance from the site.
7. U.S. Park Police is respectfully requested to post “No Parking” signs on the east and west sides of Daniel French Drive, SW, from 23rd Street, SW, to Independence Avenue, SW. The restriction should be in effect from 05/03/2020 at 0600 hours until 05/03/2020 at 2200 hours. This is for line of sight concerns, stand-off distance from the site.
8. U.S. Park Police is respectfully requested to **SHUT DOWN ALL VEHICULAR AND PEDESTRIAN TRAFFIC** on Daniel French Drive, SW, from 23rd Street, SW, to Independence Avenue, SW. The restriction should be in effect from 05/03/2020 at 0600 hours until 05/03/2020 at 2200 hours. This is for line of sight concerns, stand-off distance from the site.
9. U.S. Park Police is respectfully requested to **SHUT DOWN ALL VEHICULAR AND PEDESTRIAN TRAFFIC** on Rock Creek Drive, NW, and all access roads from Virginia Avenue, NW to Ohio Drive, SW from 05/03/2020 at 1200 hours until 05/03/2020 at 2200 hours.
10. U.S. Park Police is respectfully requested to post “No Parking” signs on the east and west sides of Parkway Drive, NW from Peters Point south to Lincoln Memorial Circle, NW. The restriction should be in effect from 05/03/2020 at 1200 hours until 05/03/2020 at 2200 hours. This is for line of sight concerns, stand-off distance from the site.
11. U.S. Park Police is respectfully requested to post “No Parking” signs on both sides of West Basin Drive, SW from Ohio Drive, SW, north to Independence Avenue, SW. The restriction should be in effect from 05/03/2020 at 1200 hours until 05/03/2020 at 2200 hours. This is for line of sight concerns, stand-off distance from the site.
12. U.S. Park Police is respectfully requested to **SHUT DOWN ALL VEHICULAR AND PEDESTRIAN TRAFFIC** on the Arlington Memorial Bridge at Memorial Circle in both directions from 05/03/2020 at 1200 hours until 05/03/2020 at 2200 hours. This will include any and all access points to Lincoln Memorial Circle, 23rd Street, Ohio Drive, SW, Independence Avenue, SW, Constitution Avenue, NW, and the Rock Creek Parkway.

13. U.S. Park Police is respectfully requested to **SHUT DOWN ALL VEHICULAR AND PEDESTRIAN TRAFFIC** on Independence Ave in both directions from West Basin Drive, SW to Ohio Drive, SW from 05/03/2020 at 1200 hours until 05/03/2020 at 2200 hours.
14. U.S. Park Police is respectfully requested to **SHUT DOWN ALL VEHICULAR TRAFFIC** on Independence Ave in both directions from Maine Avenue, SW, and 15th Street, SW, to West Basin Drive, SW, for arrival and departure of the motorcade.
15. U.S. Park Police is respectfully requested to provide officers to augment USSS personnel on the exterior perimeter.
16. U.S. Park Police is respectfully requested to have a tow truck available for the duration of the visit to remove any unauthorized vehicles parked in the restricted areas.
