The crowd continues to maintain its size outside of the Supreme Court building along 1st Street NE with participants reaching approximately 500 demonstrators.

USCP has been working several medical calls for service related to heat casualties. Two cooling buses are being deployed by HSEMA to assist with heat mitigating measures.

Arrests were made by USCP for two individuals that were identified as throwing paint on to the fencing/bike rack that was deployed for crowd management.

The main contingent of the USPP special detail has reported and the roll call briefing and assignments have been finalized. USPP assets will concentrate their efforts in the monumental core area and the park lands adjacent the U.S. Capitol/Supreme Court that are commonly utilized as staging locations for non-permitted 1st amendment activities and/or nefarious activities.

The crowd size is less than 500 demonstrators with a few identifiable counter protestors mixed within the crowd.

A group of approximately 40 individuals dressed in all black met in Folger Park. The group then marched to the SCOTUS, then east on "D" Street NW to 7th Street NW. They then marched back to SCOTUS where the majority of the group dispersed. During their march, the group burned a few flags and spray painted a city street.

A small group of approximately 40 individuals remain at the SCOTUS. No NPS resources have been impacted by these protests.

USPP Special Detail has been demobilized.

A group who's permit was denied for Columbus Circle has violated that denial and began to set up tents, stages and sound equipment in the park.
