Dear Ms. Lambert,
My name is Justina Fugh, and I am the Director of EPA's Ethics Office. I am writing to explain that Joe Goffman will not be able to respond to your request nor will he be able to meet with you. As a political appointee, Mr. Goffman signed the Biden Ethics Pledge as required by Executive Order 13989. He is prohibited from participating in any particular matter involving specific parties that relates to his former employer, Harvard University. Unfortunately, this restriction means that he is unable to act upon your request and cannot meet with you or even direct you to someone else in his office. For two years, he is fully recused from engaging as part of his official EPA duties with any representative from Harvard.

Should you wish to meet with EPA's Office of Air and Radiation, then please send your request to Ann (Campbell) Ferrio, chief of staff of the Office of Air and Radiation, copied here. Ms. Ferrio will consider your request and, if appropriate, route it to the correct part of her office.

Thank you for your interest in the work of this Agency, and I hope that you understand why it is important to Mr. Goffman and EPA that he navigate his ethical obligations carefully.
