Dear Senators Collins and Reed and Representatives Diaz-Balart and Price:

On behalf of the members of the States for Passenger Rail Coalition, Inc. (SPRC), I am writing to urge you to include language to allow the United States Department of Transportation (USDOT) to execute appropriations for Amtrak under a Continuing Resolution (CR) in the new budget account structure as provided by the Fixing America's Surface Transportation Act (FAST Act - division A of Public Law 114-94), and subsequently adopted in the Federal Fiscal Year FFY 2017 House Appropriations sub-committee-reported, and Senate-passed bills.

The language is critical and necessary to support the implementation of other provisions of the FAST Act related to Amtrak services on State-Supported routes.

SPRC state members sponsor 29 - intercity passenger rail routes serving 296 communities across America. Last year our trains carried almost 15 million passengers, representing 48% of Amtrak's total ridership. In FFY2015, we also contributed \$711 million in revenues to Amtrak, through \$489 million in passenger revenues plus \$222 million in contract payments, representing approximately 35% of Amtrak's total revenues.

SPRC both supports the FAST Act and greatly appreciates the efforts of your subcommittees to provide much needed investment in intercity passenger rail.
