On behalf of the undersigned organizations, we write to express our strong support for R. Alexander Acosta, Dean of the Florida International University College of Law, who is nominated to serve as Secretary of the U.S. Department of Labor (DOL).

Businesses continue to face a great deal of uncertainty due to regulatory overreach by the previous administration. President Trump has issued numerous, vitally important executive orders aimed at quickly addressing the regulatory challenges facing the business community and to ensure employers can focus on creating jobs and growing the economy.

Mr. Acosta is a dedicated public servant who has spent years wrestling with complex legal issues, and he has proven management and federal agency experience.
