Dear Speaker Ryan, Democratic Leader Pelosi, Majority Leader McConnell, Democratic Leader Schumer, Chairman Brady, Ranking Member Neal, Chairman Hatch and Ranking Member Wyden:

The undersigned organizations, representing a wide range of business, energy, transportation, real estate, and agriculture stakeholders with millions of employees, urge Congress to pass a seamless multi-year extension of the "tax extenders" as soon as possible. Extension of these tax provisions is not only consistent with sound economic and tax policy, but will also support jobs nationwide.

The expiration of these tax provisions in 2016, and the failure to extend them before the end of 2017, has negatively impacted businesses and individuals that make important planning decisions based on tax policy. Every day that these provisions remain lapsed creates further confusion and uncertainty for taxpayers, while needlessly undermining economic growth and job creation in the private sector.

Accordingly, we respectfully ask that Congress immediately pass a seamless multi-year extension like the package included in S. 2256. We look forward to constructively working with you to achieve this important goal. Thank you in advance for your consideration.
