## Members Finalized for Joint Budget and Spending Reform Panel

Congressional leaders have named the 16 members serving on the Joint Select Committee on Budget and Appropriations Process Reform, created under the budget deal, H.R. 1892. The group has until Nov. 30 to provide “recommendations and legislative language that will significantly reform the budget and appropriations process.” Budget Chairman Steve Womack (R-Ark.) will chair the panel and set meeting agendas, along with co-chair, Rep. Nita Lowey (D-N.Y.), the ranking member on the Appropriations Committee. The report and language must be approved by a majority of the panel’s Republicans and Democrats before being offered to both chambers. The committee must convene at least five public meetings and three public hearings.
