AO FOIA Centralization Pilot Project Initial Implementation Plan

First Steps – Week of 7/24/2017

- Liz, Samantha and Troy will each identify a career manager for Becky to work with directly on this project
- Becky will meet with Brian Hope and the 3 managers identified above, both as a group and individually. Goal of those meetings will be to:
 - For group meeting:
 - discuss pilot overall
 - discuss outreach to staff
 - reach general understanding on implementation process
 - For individual meetings:
 - review all pending FOIAs for that office
 - reach agreement as to how to proceed on each
 - discuss the types of requests received by the office and look for immediate opportunities for proactive postings
- Becky will develop straw process for new FOIAs
- Ryan and Kevin will discuss FTE needs for project

Near-Term

- Implement strategy for outreach to staff
- Hold FEAT/4 offices staff and management meetings
 - Based on Becky's discussions with managers, will either meet collectively or FEAT with each office individually. Goal of those meetings will be to:
 - Discuss pilot with affected staff
 - Present strategy for addressing pending requests
 - Present straw process for new FOIAs
 - Solicit staff input on strategies for pending and incoming FOIAs
 - Address staff concerns/questions
- Implement strategy for addressing pending requests with available FEAT staff
- Finalize strategy for incoming requests
- Ryan will identify political staffer in AO for direct coordination
- As additional staff are made available to FEAT, implement strategy for incoming requests

Goal: Full Implementation of Centralization Pilot Project

- All incoming FOIA requests for OEX, OPA, OCIR, and OP will be managed as "FEAT FOIAs" and be assigned directly to the OGC FOIA Expert Assistance Team (FEAT) Office
- FEAT staff (combination of attorneys and Government Information Specialists) will review every OEX, OPA, OCIR and OP incoming request to immediately determine

whether the request is a proper request under FOIA and/or whether clarification or narrowing of the request was needed

- FEAT staff will then work with the program office staff in OEX, OPA, OP and OCIR to reach out to the requester, agree on scope of request and the search to be conducted, work with the program staff and OEI to collect responsive documents and then oversee the document review process, ensuring quality and consistency of document review
 - Existing staff in OEX, OPA, OCIR, and OP will be responsible for reviewing records consistent with the guidance and direction provided by the FEAT and for certain logistics associated with production of records to the requester
 - To ensure expeditious and efficient processing of requests, any disagreement between the FEAT Team Member and staff from OEX, OPA, OP and OCIR regarding any of the above aspects of the case will be elevated to the Director of the FEAT and the appropriate management official within the relevant office within 24 hours of the disagreement
 - Should the disagreement not be resolved at that level, it will be elevated to the Principal Deputy General Counsel (or, currently, the Acting General Counsel), who will consult and inform the Chief of Staff, as appropriate, and provide final resolution of the disagreement
- FEAT will coordinate with OEX, OPA, OP, and OCIR senior career management to ensure that they were aware of the documents being proposed for production and are prepared to sign off on those productions
- Prior to release of any documents to the public, FEAT will ensure that senior Agency leadership are given the opportunity for an awareness review of the documents to be released
- Following senior leadership awareness review, documents will be released to the requester and posted to FOIAonline
- The FEAT and affected offices will continue to look for opportunities for proactive posting of documents

SUBJECT: Office of the Administrator FOIA Centralization Pilot Project

By this memorandum, I am asking you to implement a pilot project centralizing incoming all incoming Freedom of Information Act requests directed to the Immediate Office of the Office of the Administrator, the Office of Public Affairs (OPA), the Office of Policy (OP) and the Office of Congressional and Intergovernmental Relations (OCIR) consistent with the attached project description.

This pilot project is anticipated to enhance the Agency's ability to provide effective and efficient FOIA production in response to the many FOIA requests directed to these four offices. Additionally, the pilot project will generate information on the benefits of increased centralization of FOIA processing responsibilities at the EPA and the resources necessary for such centralization. This information will be used in making near-term decisions regarding the potential increased centralization of FOIA at the Agency.

While I realize that the project will take time for full implementation, I ask that your offices begin those implementation efforts immediately. I have attached a cover memo and attachments for you to use to communicate this project with your staff and ask that you disseminate this information Monday.

Thank you for your willingness to assist in our efforts aimed at enhancing the overall efficacy of the Agency's FOIA program.

AO FOIA Centralization Pilot Project Description

All new incoming FOIA requests pertaining to OEX, OPA, OCIR, and OP will be assigned to OGC's FOIA Expert Assistance Team (FEAT). Three FTE will be added to OGC/the FEAT and will be dedicated to managing these requests as "FEAT FOIAs." As such, the FEAT will immediately review an incoming request; develop a strategy for processing that request; and then provide guidance, assistance, and direction to existing staff in OEX, OPA, OCIR, and OP, who will be responsible for reviewing records consistent with the guidance and direction provided and for certain logistics associated with production of records to the requester. The FEAT will ensure appropriate consultation with senior officials in the relevant offices through the lifecycle of a request, including providing a pre-production awareness review opportunity for material to be released and ensuring the official authorizing a response is authorized to do so under the applicable agency guidance and delegations.

For FOIA requests pending in each of the four offices at the initiation of the pilot, the FEAT Director and senior manager of the affected office will review the status of each of the requests, identify requests for which FEAT oversight would be helpful in responding to and processing the requests to conclusion and agree to a path forward for all pending requests.

This Pilot Project will generate information on the benefits of increased centralization of FOIA processing responsibilities at the EPA and the resources necessary for such centralization. That information will be used to inform a near-term decision regarding increased centralization of the EPA's existing de-centralized approach to processing FOIA requests.

To complement this project, OEI and OGC will hold FOIA management training meetings in each of EPA's program offices to ensure consistency with Agency procedures. OEI and OGC also will coordinate with the RAs to conduct new training with the Regions to ensure Agency-wide consistency.

Current Status of FOIA Processing within the AO:

- The AO Immediate Office, the Office of Public Affairs (OPA), the Office of Policy (OP) and the Office of Congressional and Intergovernmental Relations (OCIR) each receive a substantial number of FOIA requests weekly
- Each currently has many pending requests
 - Current estimates of pending requests:
 - OEX (handles AO Immediate Office FOIAs): 391
 - OPA: 107
 - OCIR: 97
 - OP: 45

- Since 1/1/2017, all four offices have seen a substantial increase in incoming FOIA requests
 - OEX alone has seen an 189% increase of incoming requests in the last 5 months
- Affected offices currently do not have sufficient staff to effectively and efficiently manage their caseloads

Centralized Management Pilot Project:

Weekly, the AO Immediate Office, the Office of Public Affairs, the Office of Policy and the Office of Congressional and Intergovernmental Relations receive a substantial number of FOIA requests. Each office is currently responsible for many pending FOIAs and unprocessed requests range from 45 in one office to nearly 400 in another office. Since January 2017 all four offices have had a substantial increase in FOIA requests: OEX FOIA receipts alone increased by 189% over a 5-month period. These four offices simply do not have sufficient staff to effectively and efficiently manage their caseloads.

To address the offices' FOIA demands, the Agency is implementing a pilot FOIA centralization project. These four offices, in conjunction with the OGC/FOIA Expert Assistance Team (FEAT), will work together to meet this unprecedented need. Below is information regarding the pilot.

AO FOIA Centralization Project Questions and Answers for Employees

How will the AO FOIA Centralization Project work for the offices?

Under the pilot, all new FOIA requests assigned to OEX, OPA, OCIR, and OP will be assigned to OGC's FOIA Expert Assistance Team (FEAT). The FEAT will immediately review an incoming request and contact the requester for clarification begin communication. The FEAT will develop a strategy for processing that request; provide guidance, assistance, and direction to existing staff in the four affected offices, who will be responsible for reviewing records consistent with the guidance and direction provided by FEAT.

The FEAT will ensure appropriate consultation with senior officials in the relevant offices through the lifecycle of a request, including providing a pre-production awareness review for material to be released. The FEAT will also ensure that the official authorizing the response does so under the applicable agency guidance and delegations.

Does this mean my office does not have to do FOIAs anymore?

No, however, what it does mean is that you will have expert assistance in managing your FOIAs, including timely outreach to requesters, enhanced coordination and consolidation of requests, and direct legal assistance in responding to requests.

If I am a FOIA Officer or FOIA Specialist, does this mean my job is being eliminated?

Not at all! You will be given expert assistance to enable you to focus your attention on document review and production.

Why is this being called a pilot?

This effort is being undertaken to address an immediate need in AO. At the end of the pilot, management will assess the project and identify the most practical, effective, and efficient way to address future AO FOIA processing requirements. In addition, the pilot project will provide data and insight regarding the benefits of increased centralization of FOIA processing responsibilities at the EPA. That information will be used to inform a near-term decision regarding increased centralization of the EPA's existing de-centralized approach to processing FOIA requests.

What about my office's existing FOIA backlog?

For pending FOIA requests in each of the four offices, the FEAT Director and each office's senior manager will review the status of each request and identify requests for which FEAT oversight will be helpful.

Will I have any opportunity to discuss the operation of the pilot?

Yes, and we are eager to hear your thoughts. The FEAT staff will schedule meetings for FOIA professionals and anyone interested in attending from each of the four offices. They look forward to meeting with you to discuss plans.

I don't like this idea. Does my office have to participate?

Senior management in all four offices have agreed to participation in the pilot program. We see this as an opportunity to effectively address the needs of the AO. Our goal is to provide some much-needed relief and assistance to the FOIA professionals in these offices.

When is the pilot slated to start?

Efforts are already underway in OPA to implement the pilot program. The FEAT is assisting OPA on its transition-related FOIAs. After additional discussions with staff and management in OPA, we will begin full implementation in that office, followed by OEX, OCIR, and OP.

I have additional questions. Can I call or talk to a manager?

Please talk with your manager. If he/she does not have answers for you, they will put you in touch with someone who will be able to discuss your questions with you. And, as the pilot project progresses, you may have more or new questions. We encourage to continue to keep an open dialogue with your manager and the FEAT as we embark on this new pilot program!

Three FTE will be added to OGC/the FEAT and will be dedicated to managing these requests as "FEAT FOIAs." As such, the FEAT will immediately review an incoming request; develop a strategy for processing that request; and then provide guidance, assistance, and direction to existing staff in OEX, OPA, OCIR, and OP, who will be responsible for reviewing records consistent with the guidance and direction provided and for certain logistics associated with production of records to the requester. The FEAT will ensure appropriate consultation with senior officials in the relevant offices through the lifecycle of a request, including providing a pre-production awareness review opportunity for material to be released and ensuring the official authorizing a response is authorized to do so under the applicable agency guidance and delegations.

For FOIA requests pending in each of the four offices at the initiation of the pilot, the FEAT Director and senior manager of the affected office will review the status of each of the requests, identify requests for which FEAT oversight would be helpful in responding to and processing the requests to conclusion and agree to a path forward for all pending requests.




Jonathan, Victor, and Ana:





Ryan- We investigated this and I wanted to report out what we learned. Bottom line: this was the result of an error by an employee in OW who uploaded them to a section of FOIAonline that was publicly available rather than the internal section of FOIAonline where we have historically uploaded documents that were undergoing the final awareness review. We have historically uploaded them to an internal section of FOIAonline as an efficiency because that could be done while the final review was occurring, and changes could still be made before the documents were published to the public side. My understanding is that the employee was Acting for his manager and may not have been very familiar with FOIAonline. To ensure this scenario will not happen again in the context of a FEAT FOIA, we will change our process so that nothing is uploaded at all until we have the final set of documents and their production has been authorized. 

Our office has been asked by the Chief of Staff to participate in a pilot project centralizing incoming all incoming Freedom of Information Act requests directed to the Immediate Office of the Office of the Administrator, the Office of Public Affairs (OPA), the Office of Policy (OP) and the Office of Congressional and Intergovernmental Relations (OCIR).

Weekly, the AO Immediate Office, the Office of Public Affairs, the Office of Policy and the Office of Congressional and Intergovernmental Relations receive a substantial number of FOIA requests. Each office is currently responsible for many pending FOIAs and unprocessed requests range from 45 in one office to nearly 400 in another office. Since January 2017 all four offices have had a substantial increase in FOIA requests: OEX FOIA receipts alone increased by 189% over a 5-month period. These four offices simply do not have sufficient staff to effectively and efficiently manage their caseloads.

To address the offices' FOIA demands, the Agency is implementing a pilot FOIA centralization project. These four offices, in conjunction with the OGC/FOIA Expert Assistance Team (FEAT), will work together to meet this unprecedented need. Below is information regarding the pilot.

Attached you will find a description of the project as well as a questions and answers document that will provide you with additional details regarding the project.

Our office has been asked by the Chief of Staff to participate in a pilot project centralizing incoming all incoming Freedom of Information Act requests directed to the Immediate Office of the Office of the Administrator, the Office of Public Affairs (OPA), the Office of Policy (OP) and the Office of Congressional and Intergovernmental Relations (OCIR).

Weekly, the AO Immediate Office, the Office of Public Affairs, the Office of Policy and the Office of Congressional and Intergovernmental Relations receive a substantial number of FOIA requests. Each office is currently responsible for many pending FOIAs and unprocessed requests range from 45 in one office to nearly 400 in another office. Since January 2017 all four offices have had a substantial increase in FOIA requests: OEX FOIA receipts alone increased by 189% over a 5-month period. These four offices simply do not have sufficient staff to effectively and efficiently manage their caseloads.

To address the offices' FOIA demands, the Agency is implementing a pilot FOIA centralization project. These four offices, in conjunction with the OGC/FOIA Expert Assistance Team (FEAT), will work together to meet this unprecedented need. Below is information regarding the pilot.

Attached you will find a description of the project as well as a questions and answers document that will provide you with additional details regarding the project.

I appreciate your cooperation in this effort aimed at enhancing our FOIA program. Thank you.


