  - 3 SECTION 1. SHORT TITLE.
  - 4 This Act may be cited as the "Preparing Localities
  - 5 for an Autonomous and Connected Environment Act" or
  - 6 the "PLACE Act".

1	SEC. 2. GRANTS FOR THE OPERATION OF A NATIONAL

4	(a) In General.—Part A of subtitle VI of title 49,
5	United States Code, is amended by adding at the end the
6	following new chapter:
7	"CHAPTER 307—NATIONAL HIGHLY

9	"SEC. 30701. NATIONAL HIGHLY AUTOMATED VEHICLE

11	"(a) In General.—The Secretary of Transportation
12	shall make a grant to an institution of higher education
13	engaged in research on the secondary influences of highly
14	automated vehicles to—
15	"(1) operate a national highly automated vehi-
16	cle clearinghouse;
17	"(2) collect, conduct, and fund research on the
18	secondary influences of highly automated vehicles;

22	"(b) Authorization of Appropriations.—There
23	is authorized to be appropriated out of the Highway Trust
24	Fund \$2,000,000 for each fiscal year, beginning with fis-

1 "(c) Applicability of Title 23.—Funds authorized by subsection (b) shall be available for obligation in 3 the same manner as if such funds were apportioned under 4 chapter 1 of title 23 except that the funds shall remain 5 available until expended. 6 "(d) Definitions.—In this section: 7 "(1) Highly automated vehicle.—The term 'highly automated vehicle' means a motor vehicle 8 9 that is capable of performing the entire task of driv-10 (including steering, accelerating and decel-11 erating, and reacting to external stimulus) without 12 human intervention. 13 "(2) Institution of higher education.— 14 The term 'institution of higher education' has the 15 meaning given the term in section 101 of the Higher 16 Education Act of 1965 (20 U.S.C. 1001). 17 "(3) Secondary influence.—The term 'sec-18 ondary influence' means the influence on land use, 19 urban design, transportation, real estate, municipal 20 budgets, social equity, and the environment.". 21 (b) DEADLINE FOR CLEARINGHOUSE.—The Sec-22 retary of Transportation shall ensure that the institution 23 of higher education who receives the grant described in section 30701(a)(1) of title 49, United States Code, as 25 added by subsection (a), shall establish the national highly
