Dear Acting Commissioner Giroir:

I write regarding your recent appointment to serve as Acting Commissioner of the U.S. Food and Drug Administration (FDA), the federal agency responsible for safeguarding the public health based on science and free from political interference. I have concerns about your appointment because during your time as the Assistant Secretary for Health at the Department of Health and Human Services (HHS), you have undermined evidence-based programs and promulgated policies based on political ideology—behavior that is antithetical to the very mission of HHS and the agency you are now charged with leading. Given your record of service at HHS, Congress and the public deserve assurances that you are committed to evidence-based decision-making and to upholding the scientific integrity of the FDA.

In your role as the Assistant Secretary for Health, you are responsible for overseeing critically important offices, including the Office of Women's Health, the Office of HIV/AIDS and Infectious Disease Policy, and the Office of Population Affairs. Though you were confirmed by the Senate to this position last year, I voted against your nomination because I was unconvinced that you would promote the use of evidence-based health policy in your role overseeing the programs of these offices.

During your confirmation process, I sought your commitment to advocate for and sustain evidence-based public health practices as Assistant Secretary for Health. In response to my questions for the record on topics ranging from reproductive health, to contraception, to HIV/AIDS, you committed to “implement[ing] evidence-based programs,” and “applying evidence and common sense to our policymaking process.”¹ Despite these “assurances,” HHS under your leadership has systematically rolled back evidence-based programs proven to improve health outcomes.

In response to my question regarding the Title X Family Planning Program (Title X), for example, you answered that you were “committed to promoting the public’s health and applying evidence and common sense to our policymaking practice.”² Yet, as Assistant Secretary, you oversee the Office of Population Affairs, which has worked to dismantle the Title X Federal

Family Planning Program. Title X is the only federal program dedicated to providing family planning services to people with low incomes. In keeping with longstanding medical, ethical, and legal standards of health care, Title X has funded basic and comprehensive reproductive health services for millions of low income Americans—including cancer screenings, sexually transmitted infections (STI) testing, and birth control—for nearly 50 years.³ But under your leadership, HHS undermined the program by implementing a rule that imposes a “gag rule” on Title X providers, loosens the evidence-based quality requirements that have defined the program from its inception, and reduces access to care for patients.⁴ As a result of the rule, a number of health care providers have withdrawn from the program. Instead, the agency has awarded family planning dollars to the Obria Group,⁵ which does not provide hormonal birth control⁶ or condoms⁷ and promotes a fertility app that “sows doubt about the pill.”⁸ In pursuing these changes, you ignored significant opposition from well-respected medical organizations, including the American Medical Association.⁹

The Office of Population Affairs also administers the Teen Pregnancy Prevention Program, an “evidence-based program that funds diverse organizations that are working to prevent teen pregnancy.”¹⁰ Comprehensive sex education programs “delay sexual debut, reduce frequency of sex and number of partners, increase condom or contraceptive use, or reduce sexual risk-taking.”¹¹ But in your time at HHS, the Department has re-written the rules of the program to emphasize abstinence-only programming, which has proven to be ineffective, if not

The rule also directly attacks Planned Parenthood by requiring facilities that receive Title X funds to be physically and financially separate from facilities that perform abortions, even though Title X funds are already prohibited from being used for abortions. detrimental, to efforts to reduce pregnancy and sexually transmitted infections.¹² Earlier this year, HHS announced that it diverted federal funding from evidence-based programs to providers that promote ineffective abstinence-only education and offer non-FDA-approved medication abortion reversal treatments.¹³ These actions violate your written commitment to me that you “intend[ed] to develop and implement evidence-based policies and programs to, among other things, decrease unintended pregnancies, and STIs among all Americans, especially among teenagers.”¹⁴

In answering my question about the HIV/AIDS Program, you also committed that you would “seek a broad diversity of opinions and include them in the public health decision making process.”¹⁵ But at HHS, you directly spearheaded the administration’s efforts to defund critical research addressing HIV and other diseases—ignoring the opposition of the American Academy of Pediatrics, the American College of Obstetricians and Gynecologists, the American Association for the Advancement of Science, and 60 other scientific, academic, and medical associations and research institutions that such a rule “would severely obstruct research that is necessary for the development of new treatments for a wide range of serious diseases.”¹⁶

As Acting Commissioner of the FDA, you are responsible for decisions that affect the health and safety of every American. Therefore, I am seeking assurances that you will set aside politics and commit to evidence-based policy making during your tenure at the agency. You have not lived up to the commitments you made to Congress and the public prior to being confirmed to your current position at HHS, and you must do better at the FDA. I look forward to receiving a written response that confirms your commitment to evidence-based policymaking at the agency by November 29, 2019.
