The U.S. Department of Homeland Security, Cybersecurity and Infrastructure Security Agency (CISA) is responsible for providing strategic guidance as assigned under the Homeland Security Act of 2002. CISA recently published "Essential Critical Infrastructure Workers," as a resource for State and local officials as they work to protect their communities while ensuring continuity of functions critical to public health and safety, as well as economic and national security. CISA has identified natural gas utility workers as "Essential Critical Infrastructure Workers" for the energy industry. Specific functions accompany the listing.
