Fact Sheet I China's Medical Supplies and Assistance to the U.S.

(Updated on April 8)

- 1. China's export of medical supplies to the U.S. between March 1 and April 8 according to China's customs:
 - N95/KN95 masks: 26,650,000
 - Surgical and other kinds of masks: 504,810,000
 - Gloves: 195, 930, 000
 - Surgical gowns: 17,250,000
 - Goggles: 873,000
 - Non-invasive ventilators: 3,253
 - Invasive ventilators: 112
- 2. China's donations to the U.S. (including Chinese provinces, cities, associations, non-governmental institutions and companies):
 - N95 masks: 400,000
 - Surgical and other kinds of masks: 1,170,000
 - Gloves: 26,600
 - Non-invasive ventilators: 1,000
 - Test kits: 500,000

	unknown cause.
12. 29	Centers for disease control and prevention and hospitals in Hubei
	and Wuhan carried out epidemiological investigation.
12. 30	Wuhan Municipal Health Commission issued an "urgent notice
	on the treatment of pneumonia of unknown cause".
12. 31	The National Health Commission (NHC) sent an expert group

	to Wuhan to investigate on site.
1.3	China began to inform the United States of the
	pneumonia outbreak and response measures on a

	briefing him about China's fight against COVID-19
	and urging the U.S. side to take an objective and
	rational approach.
2. 3	NHC Vice Minister Li Bin met with Dr. Walter Ian
	Lipkin of Columbia University in Beijing and
	listened to his recommendations about COVID-19
	prevention and control.
2.7	President Xi Jinping and President Donald Trump
	spoke on the phone. President Xi briefed President
	Trump about the epidemic developments and response
	in China, and President Trump expressed appreciation
	for China's exceptional ability of mobilization and
	response.
2.8	Secretary Azar wrote back to Minister Ma Xiaowei. In
	the letter he thanked China for including American
	experts in the WHO-China Joint Mission to China and
	hoped the Joint Mission would make the visit soon.
	He also explained about the public health measures
	recently taken by the U.S.
2.11	At the initiative of the U.S. side, Deputy Director-
	General of Chinese CDC Feng Zijian exchanged views
	with officials responsible for influenza of the U.S.

	video conference on COVID-19 control and prevention
	with medical experts from both sides.
3. 30	Minister Ma Xiaowei communicated with Secretary Azar
	on the phone about the two countries' progress and
	further cooperation in COVID-19 prevention and
	control.

Fact Sheet III China's Medical Supply and Assistance to the World (Updated on April 10)

- The Chinese government has been providing supplies to 127 countries and 4 international organizations, including surgical masks, protective gears and testing reagents. China donated \$20 million to the WHO, sent 13 medical teams to 11 countries and held over 70 video conferences with experts from more than 150 countries and international organizations. Localities, enterprises and non-governmental organizations in China donated medical supplies to more than 100 countries, regions and international organizations.
- Some countries asked China through diplomatic channels for assistance in commercial procurement, and eligible exporters were recommended to

them. China's Ministry of Commerce also published a list of certified manufacturers and facilitated the customs clearance of supplies in compliance with regulations.

- As of April 8, 58 countries and regions as well as 4 international organizations have signed contracts on commercial procurement of medical supplies with Chinese businesses, and another 71 countries and ten international organizations are in talks for such purchase. There are other foreign buyers cooperating with Chinese companies, too.
- According to statistics from China's customs, from March 1 to April 4, China exported RMB10.2 billion (US\$ 1.45 billion) worth of anti-epidemic supplies, including:

Masks 3.86 billion

Protective gears 37.52 million

Infrared thermometers 2.41 million

Ventilators 16,000

Test kits 2.84 million

Protective goggles 8.41 million
