Introduction

The Coronavirus Aid, Relief and Economic Security (CARES) Act and Paycheck Protection Program and Health Care Enhancement (PPHCE) Act provide the Department of Health and Human Services (HHS) \$175 billion under the Public Health and Social Services Emergency Fund (PHSSEF), to administer a Provider Relief and Protection Fund (PRF). Specifically, funds are available to prevent, prepare for, and respond to coronavirus, domestically or internationally. The PRF covers necessary expenses of eligible health care providers for health care-related expenses or lost revenues that are attributable to coronavirus disease 2019 (COVID-19) and not reimbursed from other sources and other sources were not obligated to reimburse. The Secretary of Health and Human Services has designated that the Health Resources and Services Administration (HRSA) will administer the PRF.

This report is the first 60-day update submitted to the Committees as requested in the CARES and PPHCE Acts reporting requirements below—the statutory reporting requirements are the same for both appropriations. As these appropriations are being implemented in coordination and the reporting requirements are the same, HHS will be reporting on the CARES and PPHCE obligations in one report.

This report includes total funding obligations from March 27, 2020, to April 30, 2020.

Reporting Requirements

Provided further, That not later than 60 days after the date of enactment of this Act, the Secretary of Health and Human Services shall provide a report to the Committees on Appropriations of the House of Representatives and the Senate on obligation of funds, including obligations to such eligible health care providers summarized by State of the payment receipt; *Provided further*, That such reports shall be updated and submitted to such Committees every 60 days until funds are expended.

HHS Provider Relief and Protection Fund Obligations Summary: 1st 60-day Update to Congress as of April 30, 2020

As of April 30, 2020, HRSA has obligated \$39.295 billion under the Provider Relief Fund, which includes \$39.274 billion for provider payments, as detailed in the table below.
