All - I want to extend a big thank you to all of you for your patience and feedback as we have worked through this issue. I know it has been frustrating and a long wait.

As you know, the WO-Lands office has been working with Forest Service leadership, the Department of Agriculture, and OMB on a resolution to issues raised in the Government Accountability Office report regarding the Forest Service's compliance with the 100th Meridian provision.

The 100th meridian provision states that except for areas specifically authorized by an Act of Congress, not more than 15 percent of the acreage added to the National Forest System under LWCF can be west of the 100th meridian. Our guidance is that "areas specifically authorized by an Act of Congress" refer to Congressionally-Designated Areas such as Wilderness, so acres in these areas are exempted from this provision.

We have received final guidance on this issue.

- USDA OGC has determined that a listing of land acquisition projects in a conference committee report does not override the 100th meridian provision in the LWCF statute.
- Under this guidance, the Forest Service must immediately implement the 100th meridian provision. All available funding (that is, funding from all fiscal years) must be allocated according to the 100th meridian provision.
- Implementing this provision means some 23,000 acres of current, funded western projects cannot be implemented under this legal interpretation.
- A list of these projects is attached.
- If a project is not on this list, we have determined that it can move forward in compliance with the 100<sup>th</sup> meridian provision.
