Other cases not directly related to COVID include, a product liability claim over a knee replacement, two disputes over medical treatment scheduling, a trust dispute, a dispute between providers over Medicare reimbursements, a complaint against a nurse staffing company for poor quality candidates, and an elder abuse case unrelated to COVID.

Most of these cases have no real connection to COVID, including: a car accident on way to COVID test, contract dispute over a barge, an employment dispute, dispute over Deloitte's failure to help Ohio's unemployment system, PI case involving plexiglass falling on a customer's foot, hair in an egg and cheese sandwich, dispute over a store tobacco permit, embezzlement, delay in renovation plans, ADA claim about a teddy bear company's screen readers, car repossession, dispute over a demolition permit, TCPA violation, dispute over a "no parking" sign, false arrest dispute, trust dispute, dispute over mobile home placement, tax dispute, cease and desist action against a day trader, and a dispute over a smokestack demolition. The three cases with a marginal connection to COVID include:

invasion of privacy regarding medical record (a COVID test), refusal to obey subpoena to testify about jail safety and COVID, and an assault case involving violation of COVID safety protocols.
