Dear Chairman Ron Johnson and Ranking Member Gary Peters,

As a bipartisan group of 33 cybersecurity experts and leaders from around the country, we write to express our support for Secretary of the U.S. Department of Homeland Security (DHS) nominee, Alejandro "Ali" Mayorkas. We echo a diverse litany of others in national security, law enforcement, and public safety to urge the U.S. Senate to swiftly schedule the confirmation hearing and approve his appointment without delay.

In light of the recent attack on SolarWinds, Mr. Mayorkas' nomination comes at a time when the cyber and digital threats we face to our critical infrastructure—vital systems such as health care, elections, emergency management, education, telecommunications, utilities, and banking—are more complex than at any point in American history. Likewise, the threat actors who plan and attempt attacks are growing more diverse and sophisticated by the day.

From collective experience, we have seen that cyber threats aimed at our nation's critical infrastructure have come in many forms: attempts to hack water or energy systems, stolen personal information or assets, foreign attempts to intervene in our democracy, and spreading of misinformation on vital topics, just to cite a few. Yet new cyber vulnerabilities have emerged as workers, businesses, and students adapted to telework or remote learning due to COVID-19. During this unprecedented pandemic, we have seen threats targeted at hospitals, medical facilities, COVID-19 vaccine supply chains, and schools, putting American lives and livelihoods in jeopardy.

Mr. Mayorkas is exceptionally well-positioned to meet these and future cyber challenges. He served with distinction as DHS Deputy Secretary under President Obama, and brings with him an immediate understanding of the vast complexities of the DHS Enterprise. Notably, his efforts advancing the Department's cybersecurity mission represented a key priority during his tenure. Well-known and well-respected across the cyber community, Mr. Mayorkas possesses the intelligence, integrity, and skills to assume leadership and protect our homeland assets—physical and cyber in nature—on day one.

History has shown the U.S. Senate to act quickly and without bias on the confirmation of national security nominees. As we know, nefarious actors, particularly those in the cyber domain who wish to do Americans harm, do not concern themselves with political timelines or party affiliations. For this reason, we again urge such swift action characterized in past precedent to approve Mr. Mayorkas, a seasoned cyber advocate and leader, as our next DHS Secretary.
