Re: Oppose Tommy Beaudreau for Deputy Secretary of the Interior

Dear Chairman Manchin, Ranking Member Barrasso, and Members of the Committee:

On behalf of our organizations, and our millions of members and supporters, we are writing to oppose the nomination of Tommy Beaudreau for Deputy Secretary of the Department of the Interior and we urge you to vote no on his nomination. Tommy Beaudreau simply possesses too many conflicts of interests with the fossil fuel industry and a lackluster record within the Department of the Interior during the Obama administration to serve in such a critical role managing our nation's public lands and irreplaceable natural heritage, not to mention tackling the climate crisis that has been caused by the very industry that Mr. Beaudreau has represented for years.

Mr. Beaudreau's financial disclosure report reveals numerous, deeply-troubling conflicts of interests with the fossil fuel industry. After leaving the Obama Administration, Mr. Beaudreau entered private practice as a Partner in Latham & Watkins's environment, land, and resource department. During this time, he represented numerous coal mining, oil and gas, pipeline development, and mining companies including: Arch Resources, Total, Beacon Offshore Energy, Epic Midstream, Unocal Pipeline, and BHP.¹

Mr. Beaudreau also appears to have done work for two Saudi Arabian companies² — Red Sea Development³ and NEOM — the latter of which is connected to Crown Prince Mohammed bin Salman.⁴ Reports indicate that the NEOM megacity project will result at least 20,000 members of the Huwaitat tribe being evicted from their tribal land.⁵ Mr. Beaudreau's many, deep

connections to the fossil fuel industry stand in stark contrast to Secretary Haaland's disclosure report.⁶

Eleven years ago, the BP Deepwater Horizon disaster killed 11 oil workers and spewed more than 210 million gallons of oil into the Gulf of Mexico for nearly three months, killing thousands of marine mammals, sea turtles, and birds. Mr. Beaudreau joined Interior shortly after the Deepwater Horizon disaster to help oversee the reform of offshore oil and gas, including the design and implementation of new regulations establishing standards for blowout preventers.⁷

Mr. Beaudreau failed to ensure that the strongest possible regulatory safeguards were implemented post-Deepwater Horizon. The rules failed to require the use of crucial safety technology such as blind shear rams on all blowout preventers by excluding them on existing floating drilling units and those currently under construction. The administration even admitted the new rules did not make the blowout preventers completely fail-safe, and it provided the industry up to seven years to comply with many of the requirements.

Mr. Beaudreau also failed to adequately address systemic problems that led to the Deepwater Horizon catastrophe. The National Commission on the BP Deepwater Horizon Oil Spill and Offshore Drilling identified systemic breakdowns in the environmental-review process for oil and gas activities as another major problem, as the Interior Department had excluded the BP Deepwater Horizon oil rig from an in-depth environmental review. Although the Commission called for significant revisions, meaningful changes never occurred at the Bureau of Ocean Energy Management (BOEM), which Mr. Beaudreau oversaw at the time. Instead, Mr. Beaudreau as the Director of BOEM, which is responsible for all offshore leasing and development at Interior, continued to rubber-stamp offshore drilling with no real review.

Tommy Beaudreau is too cozy with the industry that is most responsible for the escalating climate crisis, and would likely undermine the President's stated goal of reducing greenhouse gas emissions 50% by 2030. His conflicts of interest and industry ties, which stand in stark contrast to Secretary Haaland, are incompatible with the Department, and his confirmation would greatly hinder the protections of our most cherished natural and cultural resources.
