Dear Majority Leader Schumer, Speaker Pelosi, Chair Cantwell, and Chairman Pallone:

The undersigned K-12 education and library associations write today to urge you to include within the forthcoming Build Back Better Act at least \$4 billion to ensure that more than 5 million students, teachers and library patrons can maintain their home broadband connections beyond June 30, 2022. We hope that Congress will follow the lead of the House Energy and Commerce Committee, which has already approved that sum in its section of the Build Back Better Act.

Our organizations remain very appreciative of Congress authorizing and appropriating \$7.17 billion for the Emergency Connectivity Fund (ECF) in the American Rescue Plan Act. Right now, schools and libraries are using these funds to purchase connected devices and home Internet access services to help bridge the pernicious home connectivity gap that afflicted as many as 16 million students and 400,000 educators before COVID began. This so-called homework gap disproportionately affects Black, Brown, low-income, and rural students, making it difficult for them to carry on their studies.

We were pleased to see that demand for ECF has been extraordinarily high. Despite the Federal Communications Commission opening an initial 45-day application window over the summer, when schools were in recess and many were on vacation, schools and libraries applied for \$5.1 billion in ECF support, more than 70% of available funds. This funding paid for 9.1 million connected devices and 5.4 million broadband connections, with applications coming from every US state and territory. We anticipate that the remaining funds will be fully exhausted following next week's closure of the second application window.

While ECF funding is making incredible inroads in closing the homework gap, that funding only provides support for home broadband connections until June 30, 2022. When that funding ends, the home broadband connections established will have to terminate unless additional funding is provided. Should these home broadband connections be cut-off, students could find their online courses interrupted, their research projects and homework assignments impossible to complete, and their relationships with educators and peers shut down. Library patrons would

lose critical connections to work and healthcare, as well as remote learning. For all of these reasons, we urge Congress to include \$4 billion in additional ECF funding within the forthcoming Build Back Better Act.

We appreciate your time and attention to this matter and look forward to continuing to work with you on this significant problem.
