- 12 (2) Nearly 90 percent of solar jobs in the 13 United States are in the installation, operation and 14 maintenance, sales, distribution, and project develop-15 ment sectors, all of which heavily depend on the 16 availability of affordable solar panels.
 - (3) In 2020, solar accounted for 43 percent of all new electricity-generating capacity in the United States, representing solar's largest ever share of new generating capacity and ranking first among all technologies for the second year in a row.
 - (4) According to the Solar Energy Industries Association, the 30 percent tariff on imported solar cells and panels imposed in 2018 led to the loss of more than 62,000 United States jobs and 10.5 gigawatts of foregone solar deployment.
