Dear Chair Christian,

I write today to share my concerns with the Public Service Commission's (PSC) recent approval of upgrades to transmission lines that distribute power generated in Upstate New York to the downstate region while disproportionately increasing upstate utility rates.

A recent Times Union article entitled, "Power Lines will be Upgraded, but Who Really Pays," details the PSC's approval of necessary investments in the grid. However, it brought to light that, proportionally, Upstate New York consumers will see a steeper percentage increase in rates than downstate, with an average increase of 8.2% for upstate ratepayers versus an increase of 3.8% for downstate ratepayers.

When I voted for the Climate Leadership and Community Protection Act in 2019, it was with a commitment to protect communities throughout New York while meeting our climate goals. This commitment calls for a 'holistic just transition', providing affordability and reliability to all New Yorkers - regardless of where they live - and balancing economic burdens fairly. I believe, based on our recent conversations, that affordability and equity are priorities for you, as well.

I urge the PSC to review the current funding mechanism of building out New York State's transmission lines. Providing clean, renewable energy is of the utmost importance to achieving our climate goals. That said, disproportionately increasing utility rates for Upstate New Yorkers to subsidize the cost of expanding transmission lines that move energy downstate is certainly not in alignment with our "community protection" commitment. Almost all (91%) of Upstate New York's energy production is from emissionsfree sources, while only 9% of downstate energy production is emissions-free. Why is the cost of transmitting energy produced in Upstate New York being borne on Upstate ratepayers, rather than those actually consuming the energy?
